

Ordinance 2008-6

AN ORDINANCE FOR THE PURCHASE OF A
2008 BOBCAT A300 SKID STEER WITH ACCESSORIES
FROM BOBCAT OF ROCKFORD AND A TRAILER FROM N.I.T.E. EQUIPMENT

WHEREAS, the Village of Pecatonica, Illinois, currently is in need of a new Skid Steer and Trailer for moving and loading dried sludge at the new wastewater treatment facility; and

WHEREAS, the Village Authorities of the Village of Pecatonica, Illinois, have the authority pursuant to state statute to purchase personal property for the Village of Pecatonica, Illinois; and

WHEREAS, the Village Authorities of the Village of Pecatonica, Illinois, and/or its agents, have conducted a market search and review to determine the best cost for a Skid Steer and Trailer, and presented the results thereof to the Village Authorities for their consideration; and

WHEREAS, upon recommendation of the Public Works Contract Company Manager, the Village Authorities wish to make a purchase from Bobcat of Rockford for a 2008 Bobcat A300 Skid Steer with Accessories for the cost of \$69,911.00 and to make a purchase from N.I.T.E. Equipment for a 2008 Load Steer Trailer for the cost of \$3,595.00, all totaling \$73,506.00, (to include the trade-in of a Ford 3400 with Rotary and Finish mower blade) and to be paid in full upon taking possession thereof, and to be paid out of the Village of Pecatonica's Water, Sewer and Street Funds.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF PECATONICA, ILLINOIS AS FOLLOWS:

Section 1: That the Village does hereby authorize the purchase of a 2008 Bobcat A300 Skid Steer with Accessories and a 2008 Load Steer Trailer for the total amount of \$73,506.00 to be paid at time of purchase.

Section 2: That the Village hereby authorizes the Public Works Contract Company Manager to execute any and all documents to effectuate the purchase of said Skid Steer and Trailer.

Section 3: This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided for by law. This Ordinance shall be published in pamphlet form.
