ORDINANCE 2017-15

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE VILLAGE OF PECATONICA IN THE COUNTY OF WINNEBAGO AND STATE OF ILLINOIS FOR 2017-2018

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF PECATONICA, COUNTY OF WINNEBAGO, STATE OF ILLINOIS, as follows:

SECTION 1. That the total amount of appropriations for all corporate purposes, legally made, to be collected from the tax levy of the current fiscal year is hereby determined to be the sum of Two Hundred Four Thousand Three Hundred Six dollars and Fifty Nine cents (\$204,306.59).

SECTION 2. That the Two Hundred Four Thousand Three Hundred Six dollars and Fifty Nine cents (\$204,306.59), being the total of appropriations which are to be collected from the tax levy of the current fiscal year of the Village of Pecatonica, are for the following purposes: Corporate, Police Protection, Street and Bridge, IMRF, Social Security. Municipal Audit, and the Worker' Compensation. The appropriations were made by ordinance passed and approved July 18, 2017 and published July 19, 2017

The sum of the Two Hundred Four Thousand Three Hundred Six dollars and Fifty Nine cents (\$204,306.59) is hereby levied and subject to taxation for the current year. The specific amounts levied and assessed are as follows:

A. Corporate Tax Levy (65 ILCS 5/8-3-1) Cap: .4375%

There is hereby levied on all taxable property within the limits of the Village of Pecatonica, Winnebago County, Illinois, for General Administration and Corporate purposes the sum of \$115,334.37, as set forth as follows:

Corporate Tax Levy \$115,334.37

B. Police Protection Tax Levy (65 ILCS 5/11-1-3) Cap: .075%

There is hereby levied on all taxable property within the limits of the Village of Pecatonica, Winnebago County, Illinois, for Public Safety and Police Protection purposes the sum of \$10650.30, as set forth as follows:

Police Protection Tax Levy \$10,650.30

C. Street and Bridge Tax Levy (65 ILCS 5/11-81-2) Cap: .10%

There is hereby levied on all taxable property within the limits of the Village of Pecatonica, Winnebago County, Illinois, for Street and Bridge Repair and Maintenance purposes the sum of \$26,362.14, as set forth as follows:

Street and Bridge Tax Levy \$26,362.14

D. Illinois Municipal Retirement Fund Levy (40 ILCS 5/7-171)

SECTION 6. This levy is adopted in compliance with Public Act 82-102 as amended, commonly known as the Truth in Taxation Act (35 ILCS 200/18-55 through 18-100)

SECTION 7. That there is hereby certified to the County Clerk of Winnebago County, Illinois the preceding sums, totaling the Two Hundred Four Thousand Three Hundred Six dollars and Fifty Nine cents (\$204,306.59), which amount is required to be raised by taxation for the current fiscal year of the Village of Pecatonica for which the Clerk of the Village is hereby ordered to file with the County Clerk of Winnebago County, on or before the time required by law, a certified copy of this Ordinance.

SECTION 8. That all orders, resolutions, or ordinances in conflict herewith are hereby repealed insofar as such conflict exists and this Ordinance shall take effect immediately upon its passage, approval and publication as provided by law.
