

ORDINANCE NO. 2019-18

AN ORDINANCE AUTHORIZING ZONING MAP AMENDMENT FOR PROPERTY COMMONLY KNOWN AS “221 EAST 6TH, PECATONICA, WINNEBAGO COUNTY, ILLINOIS

WHEREAS, the Village of Pecatonica is a municipality legally formed pursuant to statute, and has a population of more than 500 inhabitants but less than 50,000 inhabitants; and

WHEREAS, Richard G. Norris is the owner of record of certain real estate commonly known as “221 EAST 6th STREET, PECATONICA, ILLINOIS”, P.I.N. 09-28-305-004 and legally described as:

Lot Two (2) and the East Eleven Feet of Lot Three (3) as designated upon the Plat of Subdivision of Block 27 of the Town of Pecatonica (new the Village of Pecatonica) the Plat of which is recorded in Book 35 of Deeds on page 70 in the Recorder’s Office of Winnebago County, Illinois; the West line of said Eleven (11) foot strip being parallel with the East line of said Lot Three (3); situated in the County of Winnebago and State of Illinois.

WHEREAS, the applicant, Richard G. Norris did apply to amend zoning classification for the property from its current classification as R-1, Residential Single Family District, to R-2, Residential Two Family District; and

WHEREAS, the current use of the subject property is a permitted use for property zoned R-2, Residential Two Family District, pursuant to Title XV, Chapter 153, of the Village Code; and

WHEREAS, on August 8, 2019 a hearing on the Application for Zoning Map Amendment was conducted by the Village Planning and Zoning Commission, and the notice of said hearing having been properly given and conducted pursuant to state statute and applicable provisions of Title XV of the Village Code.

WHEREAS, on August 8, 2019 the Village Planning and Zoning Commission did make findings of fact as to the Application for Amendment to zoning classification and did recommended approval of said Application for Amendment by a vote of four (4) ayes, zero (0) nays and three (3) absent.

BE IT ORDAINED by the President and the Board of Trustees of Pecatonica, Illinois.

SECTION 1: The recitals as stated above are fully incorporated herein by reference.

SECTION 2: That the zoning for 221 East 6th Street, Pecatonica, Illinois, PIN: 09-28-305-004, is hereby amended from R-1, Residential Single Family District, to R-2, Residential Two Family District, and said property shall be subject to all applicable Zoning Codes of the Village of Pecatonica and particularly all applicable Zoning Codes for property zoned R-2 Residential Two Family District.

SECTION 3: That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
