ORDINANCE 2019-22

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE VILLAGE OF PECATONICA IN THE COUNTY OF WINNEBAGO AND STATE OF ILLINOIS FOR 2019-2020

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF PECATONICA, COUNTY OF WINNEBAGO, STATE OF ILLINOIS, as follows:

SECTION 1. That the total amount of appropriations for all corporate purposes, legally made, to be collected from the tax levy of the current fiscal year is hereby determined to be the sum of Two Hundred Twenty Six Thousand Five Hundred Seventy Four dollars and Forty Five cents (\$226,574.45).

SECTION 2. That the Two Hundred Twenty Six Thousand Five Hundred Seventy Four dollars and Forty Five cents (\$226,574.45), being the total of appropriations which are to be collected from the tax levy of the current fiscal year of the Village of Pecatonica, are for the following purposes: Corporate, Police Protection, Street and Bridge, IMRF, Social Security. Municipal Audit, Worker' Compensation and Unemployment Insurance. The appropriations were made by ordinance passed and approved July 23, 2019 and published July 24, 2019

The sum of the Two Hundred Twenty Six Thousand Five Hundred Seventy Four dollars and Forty Five cents (\$226,574.45) is hereby levied and subject to taxation for the current year. The specific amounts levied and assessed are as follows:

A. Corporate Tax Levy (65 ILCS 5/8-3-1) Cap: .4375%

There is hereby levied on all taxable property within the limits of the Village of Pecatonica, Winnebago County, Illinois, for General Administration and Corporate purposes the sum of One Hundred Nineteen Thousand Nine Hundred Thirty Five dollars and Five cents (\$119,935.05) as set forth as follows:

Corporate Tax Levy \$119,935.05

B. Police Protection Tax Levy (65 ILCS 5/11-1-3) Cap: .60%

There is hereby levied on all taxable property within the limits of the Village of Pecatonica, Winnebago County, Illinois, for Public Safety and Police Protection purposes the sum of Twenty Nine Thousand Eighty Five dollars and Ninety Six cents (\$29,085.96), as set forth as follows:

Police Protection Tax Levy \$29,085.96

C. Street and Bridge Tax Levy (65 ILCS 5/11-81-2) Cap: .10%

There is hereby levied on all taxable property within the limits of the Village of Pecatonica, Winnebago County, Illinois, for Street and Bridge Repair and Maintenance purposes the sum of Twenty Seven Thousand Four Hundred Thirteen dollars and Seventy Three cents (\$27,413.73) as set forth as follows:

Street and Bridge Tax Levy \$27,413.73

D. Illinois Municipal Retirement Fund Levy (40 ILCS 5/7-171)

There is hereby levied on all taxable property within the limits of the Village of Pecatonica, Winnebago County, Illinois, for Municipality Contributions to Illinois Municipal Retirement Fund the sum of Sixteen Thousand Four Hundred Forty Eight dollars and Twenty Four cents (\$16,448.24) as set forth as follows:

Municipality Contributions to IMRF \$16,448.24

E. Social Security Tax Levy (40 ILCS 5/21-110)

There is hereby levied on all taxable property within the limits of the Village of Pecatonica, Winnebago County, Illinois, for Municipality Contributions to Federal Social Security the sum of Nineteen Thousand One Hundred Eight Nine dollars and Sixty One cents (\$19,189.61) as set forth as follows:

Municipality Contributions to Federal Social Security \$19,189.61

F. Municipal Auditing Tax Levy (65 ILCS 5/8-8-8) Cap:

There is hereby levied on all taxable property within the limits of the Village of Pecatonica, Winnebago County, Illinois, for the Municipal Auditing Tax the sum of Five Thousand Seven Hundred Fifty Six dollars and Eighty Eight cents (\$5,756.88), as set forth as follows:

Municipal Auditing Tax \$5,756.88

G. Workers' Compensation and Occupational Diseases Claims Levy (745 ILCS 10/9-107)

There is hereby levied on all taxable property within the limits of the Village of Pecatonica, Winnebago County, Illinois, for the Worker's Compensation and Occupational Diseases Claims the sum of Eight Thousand Fifty Nine dollars and Sixty four cents (\$8,059.64), as set forth as follows:

Worker's Compensation and Occupational Diseases Claims \$8,059.64

H. Unemployment Insurance (745 ILCS 10/9-107)

There is hereby levied on all taxable property within the limits of the Village of Pecatonica, Winnebago County, Illinois, for the Unemployment Insurance the sum of Six Hundred Eight Five dollars and Thirty Four cents (\$685.34), as set forth as follows:

Unemployment Insurance \$685.34

SECTION 3. That the summary of the levies made in this Ordinance are the following:

SECTION 4. That the total amount, the Two Hundred Twenty Six Thousand Five Hundred Seventy Four dollars and Forty Five cents (\$226,574.45) as specified above, is hereby levied and assessed against all property subject to taxation within the Village of Pecatonica according to the value of said property as assessed and equalized for state and county purposes for the current year.

SECTION 5. This Levy Ordinance is adopted pursuant to the procedure set forth in the Illinois Municipal Code and the Illinois Revenue Code.

SECTION 6. This levy is adopted in compliance with Public Act 82-102 as amended, commonly known as the Truth in Taxation Act (35 ILCS 200/18-55 through 18-100).

SECTION 7. That there is hereby certified to the County Clerk of Winnebago County, Illinois the preceding sums, totaling the Two Hundred Twenty Six Thousand Five Hundred Seventy Four dollars and Forty Five cents (\$226,574.45), which amount is required to be raised by taxation for the current fiscal year of the Village of Pecatonica for which the Clerk of the Village is hereby ordered to file with the County Clerk of Winnebago County, on or before the time required by law, a certified copy of this Ordinance. Any adjustment other than the township transfer shall be subtracted from or added to the Workman's Compensation levy.

SECTION 8. That all orders, resolutions, or ordinances in conflict herewith are hereby repealed insofar as such conflict exists and this Ordinance shall take effect immediately upon its passage, approval and publication as provided by law.
