

ORDINANCE NO. 2022-10

ORDINANCE AMENDING TITLE XI, "BUSINESS REGULATIONS", CHAPTER 111, "ALCOHOLIC BEVERAGES", SECTION 111.03, "NUMBER OF LICENSES", SUBPARAGRAPH (A)(1), SECTION 111.36, "FEES", AND SECTION 111.37, "PAYMENT OF APPLICATION", SUBPARAGRAPH (A), OF THE CODE OF PECATONICA

WHEREAS, the Illinois Liquor Control Act of 1934 authorizes municipalities to issue local liquor licenses and regulate the sales and use of liquor within the municipality; and

WHEREAS, the Village of Pecatonica has adopted a liquor ordinance which, among other regulations, provides for various types of local liquor licenses, the days and hours for operation and sales under those licenses, and the fees for each license type; and

WHEREAS, the corporate authorities of the Village of Pecatonica have deemed it in the interest of the residents of the village and licensees operating within its jurisdiction to amend the local liquor ordinance regarding when liquor license fees are due for applicants of Class A licenses.

BE IT ORDAINED, by the Village President and Board of Trustees of the Village of Pecatonica, Illinois:

Section 1. That Title XI, "Business Regulations", Chapter 111, "Alcoholic Beverages", Section 111.03, "Number of Licenses", Subparagraph (A)(1), is hereby amended to read as follows:

- (1) Eight Class A licenses;

Section 2. That Title XI, "Business Regulations", Chapter 111, "Alcoholic Beverages", Section 111.36, "Fees", is hereby amended to reflect under "Annual License Fee" that Class A license fees are to be paid in two equal installments.

Section 3. That Title XI, "Business Regulations", Chapter 111, "Alcoholic Beverages", Section 111.37, "Payment of Application", Subparagraph (A), is hereby amended in its entirety and shall read as follows:

(A) Applicants for a license hereunder shall, at the time of application for such license is made, pay the Village Clerk the entire fee; except that Class A applicants shall pay one-half the annual fee for such license and the remaining one-half six months from the date of issuance of the license. If a Class A license is applied for with less than six

months remaining in the Village's fiscal year, the applicant shall pay the entire fee at time of application.

Section 4. This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
