

**VILLAGE OF PECATONICA
ORDINANCE NO. 2025-05**

**AN ORDINANCE ADOPTING SCHEDULE OF MEETINGS
OF THE VILLAGE OF PECATONICA, ILLINOIS**

WHEREAS, the Village of Pecatonica, Illinois ("Village") conducts regular public meetings regarding the business of the Village; and

WHEREAS, the Village publishes a list of regularly scheduled meetings in addition to posting the agendas of those meetings in compliance with the Illinois Open Meetings Act; and

WHEREAS, the Village wishes to adopt a schedule of regular meetings for the remainder of the 2025 calendar year as set forth on Exhibit A attached to this ordinance; and

WHEREAS, the Village finds that it is in the best interest of its citizens to adopt the schedule of meetings set forth in Exhibit A.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF PECATONICA, WINNEBAGO COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. The foregoing recitals are incorporated herein and made a part hereof.

Section 2. The meeting schedule attached hereto as Exhibit A is hereby adopted and the Village Clerk is directed to publish the schedule on the Village website and in any other manner prescribed by law.

Section 3. The Village reserves the right to schedule additional meetings not included in Exhibit A as are needed and will publish notice of those meetings as prescribed by law.

Section 4. To the extent this Ordinance contradicts any previous orders, resolutions, ordinances or parts of orders, resolutions and ordinances of the Village, this Ordinance shall control and all other orders, resolutions, ordinances or parts of orders, resolutions, and ordinances in conflict herewith are hereby repealed insofar as such conflicts exist.

Section 5. All other orders, resolutions ordinances or parts of orders, resolutions, and ordinances of the Village of Pecatonica, Illinois not in conflict with this Ordinance shall remain in full force and effect.

Section 6. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
